arvy 3a Strolling Strategy

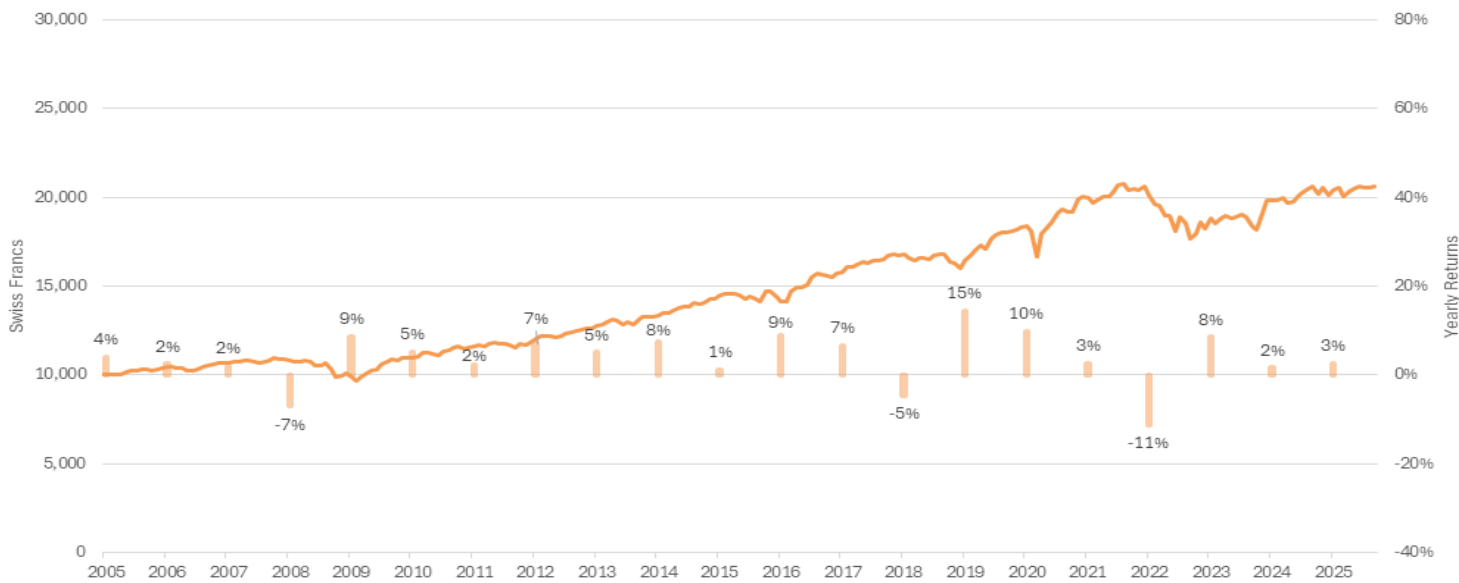

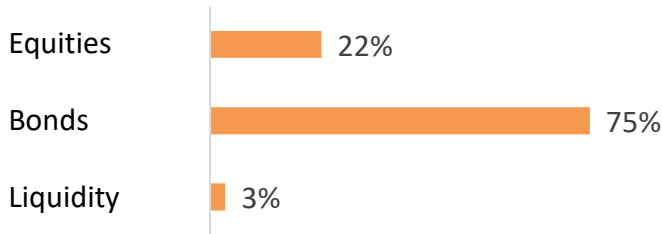

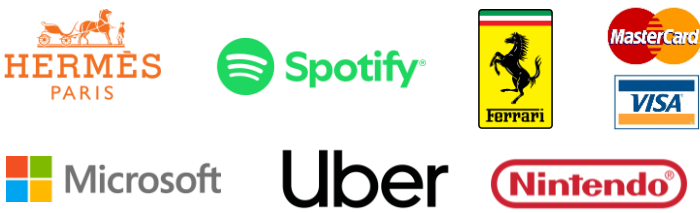
